There was high water at the plant and lift station from all the rain. DEP was notified and cleanup was done. Drayer came out to test motors and controls. The motor is possibly burnt up. There were several call outs for grinder pumps and high water.

Road Superintendent Report - Pete stated the road crew is getting the roads ready for tar & chip. There were several roads that got washed out from all the rain. Eight loads of millings had to be hauled to Porter Road. The hose on the backhoe broke and needed repaired.
