There were a couple call outs for high water and three call outs for grinder pumps.

Road Superintendent Report – Pete stated the roads have been graded and are ready for tar & chipping. The John Deere shaft had to be repaired. The pump on the Massey needs repaired. There is a bump on Aarons Road that needs milled.
